1. Novice Mini Event 2'-11"

Dressage: USEF Novice Test B
XC/Stadium: 2'-11" max.

2. Beginner Novice Mini Event 2'-7"

Dressage: USEF Beginner Novice Test B
XC/Stadium: 2'-7" max.

3. Starter Novice Mini Event 2'-3"

Dressage: USEF Beginner Novice Test A
XC/Stadium: 2'-3" max.

4. Pre-Novice Mini Event 18"

Dressage: USEF Beginner Novice Test A
Stadium/XC: 18" max.

5. Ground Poles Combined Training

Dressage: USDF Intro Test B
Stadium: ground poles (at the trot) in low fenced
dressage arena immediately after dressage phase.

A combined test will be run if XC is canceled due to weather or footing

All dressage classes are in a small 20mx40m dressage arena

RULES AND DIRECTIONS

Please take the time to read through the rules and directions. Many questions can be answered below even though it is tedious reading!

AWARDS A sash will be awarded for first place in each Mini Event division and ribbons for second through fourth place. For dressage classes, ribbons will be awarded first through fourth place.

LOW DRESSAGE SCORE Horsey Habit is sponsoring an award for the lowest (best) overall Mini Event dressage score!

HIGH DRESSAGE SCORE Horsey Habit is sponsoring an award for the highest (best) regular dressage class score!

STALLS & TRAILER TYING **Very limited stalls available** - assigned in order of when **payment** is received. We do run out, so enter and **pay** early! Overnight stall registrants are given first priority. Sunday stalls will be assigned if available. There are a few stalls in the main barn with a dozen in the outdoor three-sided stall shed. Must supply own bedding and clean upon departure. Your \$25 clean stall check will be torn up for any completely stripped stalls found at the end of show. Wheelbarrow and pick available for use. Day of event trailer tying allowed. No overnight trailer tying.

ENTRIES Entry registration starts with the online Google Form. However, rider's official date of entry is the postmarked date of when **full payment has been received**. Delaying payment may result in being wait listed or incurring higher fees. We do fill up on or before the closing date so please use due diligence in getting your payment in or you may be bumped by a more timely entrant. **Afternoon dressage entries:** preference will be given to those trailering in with a group as we have very limited parking.

FREE SUNDAY STALL DRAWING All COMPLETE EARLY BIRD pre-entries (check, entry form, online entry, releases, coggins) received will be entered in a drawing for a free Sunday stall!

SQUARE CASH You can pay fees through **Square Cash** app or cash.me website to \$Duneriders -or-

duneridersponyclub@gmail.com. You can pay using your debit card or credit card. When asked what it is for, enter "Mini Event" and rider's name. Payment is received by us within minutes! However, please submit a separate check to cover clean stall refunds as we will tear up checks for any clean stall found at end of event.

- CLOSING DATE** Saturday, August 19. We now have a tiered payment date system. See fees on the fees page below. We will keep all envelopes/Square Cash emails as proof of postmark date on payments and paperwork.
- REFUNDS** Withdrawals allowed before closing date minus a \$25 office fee. No withdrawal refunds will be given after closing date unless we receive a note from your vet or doctor. No refunds given due to weather.
- RULES FOR PENALTIES** This is a fun and low key mini event, therefore if you are eliminated, you will be allowed to continue in the current phase and any phase thereafter unless there is a question of safety. Penalties for cross country and stadium will follow USEF rules for eventing. These include run-outs, refusals, prolonged stops, a step backwards, falls, circling, and knocked downs. They can be found on the USEF website: <https://files.usef.org/assets/YxmQTKYt2GM/13ev.pdf> Any concerns regarding scoring please refer to the above website prior to making an inquiry at the Registration table. Personal due diligence is appreciated. **NO** trainer or parent inquiries permitted.
- XC SPEED** Our optimum times for cross country are much more gracious than what you would find at a recognized event. Safety is our greatest concern and ultimately this is a learning environment!
- STADIUM JUMPING** Stadium Jumping will **not** be timed. Also, you must wait for the bell/whistle from the judge before you are allowed to attempt the first fence. Please be aware that rules for stadium are different from hunter shows. See the above link for the specifics. In gate person will try to remind riders but will not be held responsible if forgotten.
- DRESSAGE RIDE TIMES** Emailed to all valid emails. Ride times begin with Novice level, starting at 8am. Readers for dressage tests are **allowed** and no points deducted for having a reader. Ground poles Stadium Jumping portion will be in the dressage arena immediately after all the ground pole division's dressage tests. Please be aware that the fencing for stadium jumping is dressage fencing height, roughly 18". Regular dressage tests (Classes A-F) will then begin in dressage arena after ground poles have been removed.
- DRESSAGE CLASSES** Because of limited trailer parking, an individual horse must be entered into two or more dressage classes.
- ATTIRE & TURNOUT** Casual show attire allowed. Braiding is not required. **Helmets** meeting current ASTM/SEI standards are required when mounted along with hard soled, heeled footwear. **Protective vests** suggested for cross country. **Medical Armbands/Bracelets** are required for all Pony Club members and suggested for all riders.
- FOOD** Food truck on the grounds.
- SCHOOLING XC** Saturday, August 26. **Schooling is strongly urged** and available the day before the show for a fee. See fees below. You can use a DRPC Instructor or your own instructor. **No riders allowed out alone on course regardless of ability or trainer status.** Schooling with DRPC Instructor will be scheduled roughly between 11am - 2pm and ride times will be emailed to you by Thursday. Schooling with own trainer is open between 2-5pm. Please be considerate of other groups when schooling. **XC courses will be posted on Sunday morning.**
- OVERNIGHT CAMPING** Overnight camping is allowed in the trailer parking area. No electric hookups available. No overnight tying of horses allowed.
- PARKING** Please follow parking attendant's directions on where to park. Be sure to park your trailer in the middle of the striped trailer parking stalls in consideration of those trailer tying. **Carpooling (Trailerpooling?) is advisable** as we have limited trailer parking. Cars will not be allowed to park back by the trailers as space is limited. **Parking of cars** will be up against the east gravel drive's rope fence before the trailer parking area.

Barn Rules-

Welcome to Wild Wind Farm



- 1) Everyone (riders and guests) involved with equine activities on the farm, mounted or not, **MUST** have a signed release form on file before engaging in such activities. No exceptions. Persons under 18 may not ride unsupervised without owner's permission and parents written permission.
- 2) Riders under 18 years of age must wear an approved equestrian helmet with the buckle fastened at all times when mounted. We encourage ALL riders to wear protective helmets. A signed Helmet Release Waiver must be on file if choosing to disregard this notice.
- 3) No Smoking in or near any of the farm buildings.
- 4) The barn phone is set-up for 911 outgoing emergency use only.
- 5) Closed toed shoes are required in the vicinity of horses. No sandals, or flip flops will be allowed!
- 6) Please clean up after yourself and your horse. Clean up manure immediately. Do not wait until after you ride. Keep your items in a tidy fashion.
- 7) Do not leave horses unattended tied, cross-tied, etc.
- 8) Barn aisle should be kept clear of tack and "horsy" supplies. Return rakes, shovels, forks, etc. to the appropriate storage area when finished.
- 9) Close all gates and stall doors.
- 10) All children must be supervised.
- 11) Please do not bring your dog. If you must bring your dog, you must keep him/her on a leash or in your car at all times.
- 12) No speeding into the driveway- small animals live here too!
